LIMITS OF LIABILITY

The limit of the Insurer's liability:

(i) shall apply exclusive of indemnity provided for under Supplementary Payments;

(ii) shall not exceed the following amounts;

except as otherwise provided in the Policy:

(A) General Liability - \$20,000,000 any one Occurrence

(B) Products Liability - \$20,000,000 any one Occurrence and in the aggregate during the Period of Insurance

(C) Advertising Liability - \$20,000,000 any one Occurrence

Should more than one Limit of Liability be applicable to any one Occurrence in respect of (A) and (C) above, such Limits of Liability shall not be aggregated - the highest single Limit of Liability only shall apply.

SUB-LIMITS OF LIABILITY

Care, Custody or Control - \$1,000,000 any one occurrence and in the annual aggregate


Errors and Omissions (Claims Made) - \$1,000,000 any one occurrence and in the annual aggregate
